#### Verification Criteria and GHG Programme

The verification was performed on the basis of ISO 14064-1:2018, GHG Protocol Corporate Accounting and Reporting Standard and GHG Protocol Corporate Value Chain (Scope 3) Accounting and Reporting Standard as well as criteria given to provide for consistent GHG emission identification, calculation, monitoring and reporting.

The verification was conducted in accordance with ISO 14066:2023, ISO 14065:2020, ISO14064-3:2019
